This report presents an overview of our key activities, financial performance, and major developments during the past year.

About Us

Our Trust was established in 2007 by a small group of friends in Chennai, driven by a vision to help the helpless and empower the underprivileged. We began by providing educational kits to poor students and later extended our support to orphans at the "Love Foundation" in Minjur.

As our work gained recognition, more individuals began reaching out to both support and benefit from our initiatives. Over time, our area of operation expanded significantly. Today, we support students from government institutions in **Chennai, Pondicherry, Kanchipuram, Mayiladuthurai, Kumbakonam, Erode, Salem, and Nagercoil.**

Our two flagship programs are:

- **Kalvi Karuvi**
- **Kalluri Kalvi Udhavu Thogai**

These initiatives offer educational and financial support to rural students in Tamil Nadu. We have been granted approval from the **Income Tax Department** for donations to



be tax-deductible. In 2024, we also received approval to accept **CSR funding** and **foreign donations (FCRA)**.

Kalvi Karuvi Program

Through this program, we provide educational kits (valued at approximately ₹2,000 per student) to students from Classes VIII to XII. Last year, we distributed **330 kits**, and to date, we have supported approximately **4,000 students**.

Evening Tuition Centre

We are running an **Evening Tuition Centre** at Michealpalayam in Erode district, continuously for the past **ten years**. Additionally, since 2008, we have been supporting the inmates of the "**Resource Centre**" in Nagercoil.

To help our students build confidence and life skills, we organize **English speaking and motivational classes** in both **online and offline** modes. From this year onwards, we have planned to conduct **one motivational session every month**, covering topics such as financial literacy, use of technology in academics, time management, and more.

Our Vision

To empower the poor, underprivileged, and downtrodden—irrespective of caste, creed, religion, or background—by providing access to education, and helping them become dignified, productive members of society.

Our Mission

To ensure access to quality education for every citizen, and to help realize the Government's vision of "**Right to Education**", especially in rural areas, while also supporting the urban poor in need.

Major Developments

Our Trust website was revamped by M/s. **Salix Technology**. The newly redesigned site was inaugurated on **October 6, 2024**, by **Shri K KrishnaKumar**, our former President, well-wisher, and principal donor.

On this occasion, Shri K KrishnaKumar also received the first copy of the "**Student Profile**", which was recently prepared by the Trust. Over the years, around **42 students** have received assistance from our Trust—starting from **Class VII**, continuing through graduation, post-graduation, and even **Ph.D.** studies. In **January 2024**, our Trust received **approval from the Government of India** to accept **foreign donations**. However, our website did not initially have a provision for online payments. Previously, it only displayed bank account details for donations.

Recognizing this gap, we upgraded the site with **two payment gateways**—one for foreign donations and the other for domestic contributions. With the help of a new software vendor, this functionality has now been fully implemented.
